

Integr8 Dance Membership Terms and Conditions

Your Membership

- A. You must complete an online consent form before becoming an Integr8 Member. This will ensure that we have up to date contact and medical information.
- B. Members will receive a % discount on workshop, summer school and dance party bookings as well as Integr8 Uniform unless otherwise stated. This discount will only be applied for the name on the membership.
- C. Members may receive priority emails about events and workshops.
- D. Your membership applies to you personally: you cannot lend, assign or transfer it to another person.
- E. We reserve the right to implement a waiting list for training at any time if we deem it necessary to do so.
- F. We reserve the right to make or change minor points or amendments in this Membership Agreement.

Payment of Fees

- A. By completing the application form and agreeing to be bound by these Terms and Conditions; you agree to pay all Integr8 Dance membership and other fees on time.
 - B. In addition to the Membership fees, we also charge fees for workshops, summer schools, private classes, trips etc. These will be charged at the full price or discounted rate if applicable to your membership.
 - C. Your membership fees are subject to periodic increases and we reserve the right to pass on any changes in the rate of VAT to you. Fees will normally be reviewed on an annual basis but circumstances may dictate an earlier revision. You will normally be given one month's notice of any fee change.
 - D. Paying monthly by Direct Debit. A direct debit will be taken through Gocardless on the 2nd of each month.
 - E. Late Payment and Missing Payments: If for any reason a payment fails from your account we will contact you to let you know. If the payment hasn't been made by the 10th of the month a late payment charge of £10 will be sent to you via invoice. This will be due 14 days from the date invoiced. Failure to pay the late payment charge and fees will mean dancers will be unable to attend classes.
 - F. Setting up a membership mid year: On setting up a membership part way through the academic year contact must be made with the office manager to discuss a suitable payment plan. There may be a charge to balance fees before monthly payments commence.
 - G. Cancelling a Direct debit is cancelled without prior consent an itemised bill will be sent for the full price of all classes up to the point of cancellation with the amount already paid via standing order deducted from the total. This full amount will then be due for payment.
 - H. Terminating a direct debit due to injury or ill health: If ill health, injury or personal circumstances affect the ability to continue training we will accept cancellation of the direct debit as long as we receive written notification prior to cancellation.
 - I. Class Cancellation. If we decide to cease running a class, there is no alternative class to transfer to and the level of dance pass no longer benefits you, Integr8 dance will either down grade your dance pass or you may cancel your direct debit. There may be a charge to balance fees before termly payment continues.
 - J. All monthly payments made are non-refundable.
 - K. Memberships are for a commitment of 12 months, when taken out in September. Memberships taken out later in the academic year will be committed to until the end of August. To cancel a membership please contact the office manager, a month's notice will be needed.
